- Principal, Faculty, Teaching and other supporting staff shall be appointed as per norms prescribed by AICTE/University from time to time and the representative of the University shall be associated in the selection process.

- The institution shall furnish requisite returns as prescribed by the University for ensuring maintenance of standards.
- The institution shall be visited by an officer or a committee of the university to inspect and review the progress made by the institution in fulfilling norms and procedures as laid down by the AICTE/University.
- The institution shall not charge any Capitation fee or donation for admission or other higher charges from students or their guardians in any form.
- The institution will have an independent building as per norms of the University with a separate approach.
- This order shall stand cancelled in case the college fails to deposit Affiliation fee (unless specifically exempted) by the due date.
- The affiliation is subject to strict compliance of Anti-Ragging regulations.
